**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF
IRVINE FITNESS 1, LLC**

1. The Articles of Organization of the Company are hereby amended by deleting the present form of Article I, in its entirety and by substituting, in lieu thereof, the following:

ARTICLE I

Name, Mailing Address and Purpose of Organization

"The name of this limited liability company is Largo Fitness 1, LLC (the "Company"). The Company's principal address and mailing address is 1227 N. Franklin Street, Tampa, FL 33602.
