ARTICLES OF ORGANIZATION
OF

Pursuant to (1) the Florida Revised Limited Liability Company Act, Chap. 605, Florida Statutes, and (11) the Professional Service Corporation and Limited Liability Company Act, Chapter 621 of the Florida Statutes (together the "Acts"), the following are adopted as the Articles of Organization of the professional limited liability company organized hereby:

ARTICLE I - NAME

The name of the limited liability company (the "Company") shall be John W. Caven, Jr., PLLC.

ARTICLE II - ADDRESS
