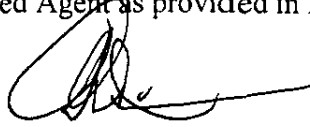

Management

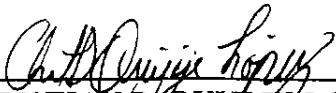

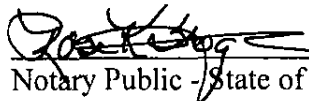

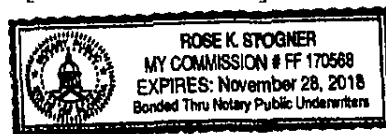
