**ARTICLE I  
NAME**

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by the approval of the member of the Company.

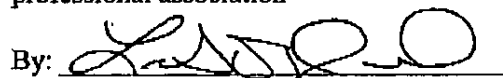
