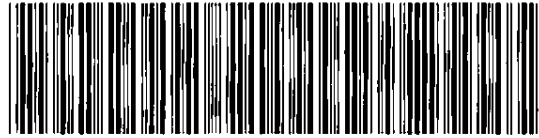

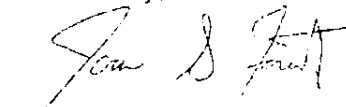
Dear Sir or Madam:

**FIRST AMENDMENT TO ARTICLES OF ORGANIZATION  
Of  
DAWSON CENTER ACQUISITION LLC**
