I recently called Sunbiz once I finally got my notice for license renewal that I wasn't expecting for this year because I thought the State has resolved my electronic form issues already. I'm not suppose to renew my license until January 2018. I had issues with the form malfunction on submission in October. It kept wiping out information after hitting the "Submit" button. It took me several times of refilling out the form to finally get it to go through and when it did it left the opening date blank. I had a few email correspondences about this issue and not being able to obtain a copy of my license and was told my date issue had been corrected but since getting this email for renewal I have found out nothing had been changed with the date situation. Please note that your emails are coming through my email server extremely late or I am not receiving them at all. I do get emails from most of my other company correspondence so I'm not sure why I have not been receiving things that come from Sunbiz or anything that has been related to my business license. Even the renewal notice seemed to be several weeks old on the date it was sent as to when I actually received it. I have your email addresses set to my whitelist so this doesn't seem to be the problem. I thought you should be aware just in case others were having this same issue. I was told to fill out a Statement of Corrections to finally fix my licensing date issue.

My operation date had been set on the electronic form for 1/1/17 in October when I submitted it. I had to set it for that date due to still being under medical care for treatments last year for a very difficult illness that I have been going through. These treatments had been working, but I relapsed on them just after the first of the year, so I could not open for business on that date. I have been trying to find a way to remedy my situation so I can open and am currently on new treatments with hopes to be able to try and open on 5/1/17. I was under the impression I needed to stick to the original date I had set for the beginning of this year after speaking to Sunbiz recently, but if possible since I was not able to open at that time, would like to know if the date can be set for 5/1/17. I understand if this is a problem and you can only set it to the first of this year. If you have any questions about this issue you may contact me at 561-336-2775.

Enclosed is my Statement of Corrections and a check. I have been told not to worry about the renewal notice and to renew in 2018.
