NO SUITS

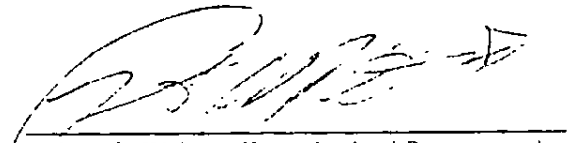
