In order to form and create a limited liability company pursuant to Chapter 605 and <u>Fla. Stat.</u> \$605.0201 of the laws of the State of Florida, we do hereby execute and adopt these Articles of Organization to be filed with the Florida Department of State and do hereby state and certify the following:
