## ARTICLES OF ORGANIZATION OF 438 DAVISON AVENUE NORTHEAST, LLC

- 1. Name. The name of this limited liability company is 438 DAVISON AVENUE NORTHEAST, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.
