ARTICLES OF ORGANIZATION
FOR
PACO'S RANCH, LLC

ARTICLE I - NAME

The name of this limited liability company shall be PACO'S RANCH, LLC.

ARTICLE II - DURATION

The limited liability company shall have perpetual existence.
