**ARTICLES OF ORGANIZATION
OF

The undersigned, Philip L. Gibson, a natural person competent to contract, and an authorized representative of TGS of Northwest Florida, LLC, hereby presents these Articles of Organization as the Articles of Organization of TSG of Northwest Florida, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is TSG of Northwest Florida, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The mailing and street address of the Company's initial principal office is 13 Center Street, Gulf Breeze, Florida 32561.

ARTICLE III - PURPOSE AND POWERS

The Company is organized for any legal and lawful purpose for which a limited liability company may be organized and shall have all powers and rights which a limited liability company may exercise pursuant to Chapter 605, *Florida Statutes*.

ARTICLE IV - COMMENCEMENT AND TERM OF EXISTENCE

The date for commencement of the Company's existence shall be the date these Articles of Organization are filed with the Florida Department of State. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.

ARTICLE V - REGISTERED OFFICE AND AGENT

The initial registered office of the Company is 13 Center Street, Gulf Breeze, Florida 32561, and the name of the initial registered agent at that address is Philip L. Gibson.


ARTICLE VI - MANAGEMENT
