

**Amendment to the Articles of Organization of  
GRADE A ENTERTAINMENT, LLC  
A Limited Liability Company, Established in Nov. 10, 2016**

Effective May 31, 2018, the members of GRADE A ENTERTAINMENT, LLC hereby adopt an amendment to change the current Limited Liability Company Articles of Organization to read:

**Article 1 Name:** The name of the Limited Liability Company is GRADE A ENTERTAINMENT, LLC.

**Article 2 Jurisdiction:** GRADE A ENTERTAINMENT, LLC is formed in the state of Florida.

**Article 3 Date of Filing:** The date the Articles of Organization were filed was 11/10/2016.

**Article 4 Principal and Mailing Office:** GRADE A ENTERTAINMENT, LLC 6538 Collins Ave. Miami Beach, FL 33141.

**Article 5 Duration:** The Limited Liability Company's period of duration shall be perpetual.

**Article 6 Purpose:** GRADE A ENTERTAINMENT, LLC is organized as a multimedia marketing company. Creating sound recordings, music & lyric compositions, online shows, movies, content, audio books and any emerging form of media in the future. Managing the growing opportunities of multimedia marketing through the creation of products and services.

**Article 7 Powers of the Limited Liability Company:** (1) shall have perpetual succession unless dissolved by law; (2) may adopt, alter, and use a seal, which shall be judicially noticed; (3) may make and perform such contracts, grants, and other agreements with any person or government however designated and wherever situated, as may be necessary for carrying out the functions of the Limited Liability Company; (4) may determine and prescribe the manner in which its obligations shall be incurred and its expenses allowed and paid, including expenses for representation; (5) may lease, purchase, or otherwise acquire, improve, and use such real property wherever situated, as may be necessary for carrying out the functions of the Limited Liability Company; (6) may accept cash gifts or donations of services or of property (real, personal, or mixed), tangible or intangible, for the purpose of carrying out the provisions of this article; (7) may use the United States mail in the same manner and on the same conditions as the executive departments; (8) may contract with individuals for personal services, who shall not be considered Federal employees for any provision of law administered by the Office of Personnel Management; (9) may hire or obtain passenger motor vehicles; and real property; (10) shall have such other powers as may be necessary and incident to carrying out this article.

**Article 8 Ownership:** GRADE A ENTERTAINMENT, LLC is divided in this manner: Andre Russ, 50%, and Cedric Jenkins 50% - equally possessing managing and operational power and vested rights to make strategy and financial decisions for GRADE A ENTERTAINMENT, LLC.

**Article 9 Indemnification:** Andre Russ and Cedric Jenkins are indemnified against any actions, harm, losses, lawsuits caused or incurred in the act of doing business by the Limited Liability Company GRADE A ENTERTAINMENT, LLC.

**Article 10 Organizer(s):** Andre Russ 6538 Collins Ave, Miami Beach, FL 33141. Organizer, Cedric Jenkins, 6538 Collins Ave, Miami Beach, FL 33141. Organizer, Walter Godette, 6538 Collins Ave, Miami Beach, FL 33141.

**Article 11 Registered Agent:** Andre Russ 6538 Collins Ave, Miami Beach, FL 33141 shall continue to operate in his appointment as registered agent as provided for in Chapter 605, F.S.
