
As per your email dated November 07 2016, in which you stated that "The name designated in my document is unavailable since it is the same as the Names of administratively dissolved/revoke company"


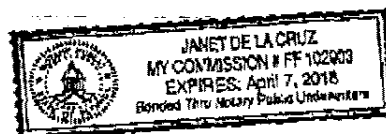
