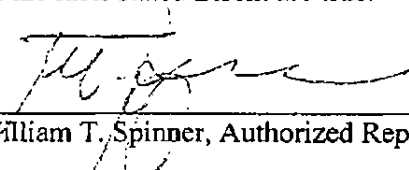
**ARTICLE V - EFFECTIVE DATE**
