**ARTICLES OF ORGANIZATION
OF
AJAX CAPITAL LLC**

The undersigned, being a duly authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is AJAX CAPITAL LLC (the "Company").

ARTICLE II. ADDRESS

The principal and mailing address office of the Company is 1450 Brickell Avenue, 18th Floor, Miami, Florida 33131.

ARTICLE III. REGISTERED AGENT AND OFFICE

The Company designates 1450 Brickell Avenue, 18th Floor, Miami, Florida 33131 as the street address of the initial registered office of the Company and names Jaime A. Orozco as the Company's initial registered agent at that address to accept service of process within this state.

ARTICLE IV. DURATION AND CONTINUATION

The period of the Company's duration shall commence with the filing of these Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated in accordance with the Company's Operating Agreement or pursuant to the Act, as amended from time to time.

ARTICLE V. MANAGEMENT

The Company shall be conducted, carried on, and managed by at least one (1) Manager and is, therefore, a manager-managed Company. The name and address of the initial Manager authorized to manage and control the Company are: Jaime A. Orozco, 1450 Brickell Avenue, 18th Floor, Miami, Florida 33131.

ARTICLE VI. PURPOSE

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida including activities within the United States and abroad.

ARTICLE VII. ADDITIONAL MEMBERS

Additional Members may be admitted upon the written consent of the majority ownership interest, and upon the written application of such new Member, in the manner set forth in the Operating Agreement of the Company, if applicable.


