TO ARTICLES OF ORGANIZATION OF
APC HOLDINGS, LLC**

THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of **APC HOLDINGS, LLC**, a Florida limited liability company (the "Company"), pursuant to the Florida Revised Limited Liability Company Act, *Florida Statutes* § 605.0202:

1. Name of Company. The name of the Company is **APC HOLDINGS, LLC**.

"3. Registered Agent and Office. The name of the initial registered agent of the Company is Andrew P. Charles. The street address of the initial registered agent of the Company is **200 4th Avenue S. #430, St. Petersburg, Florida 33701.**"

5. Amendment to Paragraph 4 of the Articles of Organization. Paragraph 4 of the Company's Articles is hereby amended by deleting the current text of Paragraph 4 in its entirety and substituting the following in lieu thereof:

"4. Management of the Company. The management of the Company shall be vested in the managers of the Company. The name and address of the initial manager of the Company is as follows:
