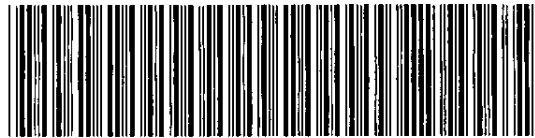

The company is organized for the purpose of holding and managing real property.




## ARTICLE X – TERMINATION OF EXISTENCE
