

## ARTICLES OF ORGANIZATION OF RIVERVIEW INDUSTRIAL PROPERTIES, LLC

- 1. NAME. The name of this limited liability company is Riverview Industrial Properties, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.
