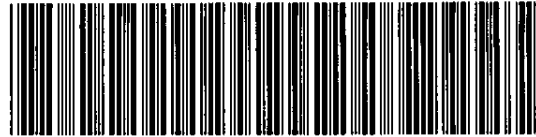

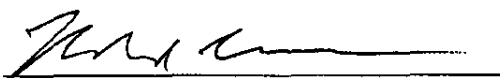

The name of the limited liability company is: Active Data Technologies, LLC.

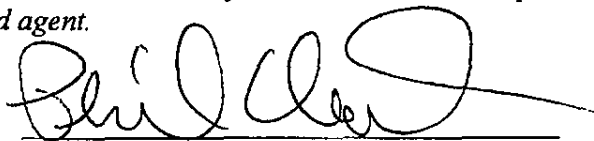
