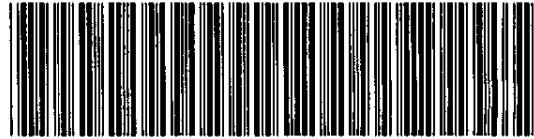

SECTION 1 INTRODUCTION AND PRELIMINARY STATEMENTS

The undersigned Organizer desires to form a limited liability company under the Laws of the State of Florida by delivering these Articles of Organization in duplicate to the Department of State of the State of Florida, in accordance with Florida Revised Limited Liability Company Act (the *Act*).

SECTION 2 NAME

The name of the limited liability company is The Med Spa by J. Christine, LLC, a Florida limited liability company (*LLC*).

SECTION 3 DURATION

The LLC will perpetually exist from the filing date of these Articles of Organization with the Department of State of the State of Florida, unless dissolved according to law.

SECTION 4 LLC'S PURPOSE

The LLC's purpose is to engage in any lawful act or activity for which limited liability companies may be formed under the Act and all activities necessary or incidental to that purpose. The LLC has all the powers necessary or convenient to carry out its purposes, including the powers granted by the Act.

SECTION 5 LLC'S PRINCIPAL OFFICE AND LOCATION OF RECORDS

The street address of the principal office in the United States where the LLC maintains its records is 2580 Executive Road, Winter Haven, Florida 33884.

SECTION 6 REGISTERED AGENT AND REGISTERED OFFICE



SECTION 7 REGISTERED AGENT CONSENT

SECTION 10 ADDITIONAL CONTRIBUTIONS

SECTION 11 ADDITIONAL MEMBERS

The LLC has the right to admit additional Members to the LLC under the terms and conditions of the LLC's Operating Agreement. Any Member who is later admitted as a Member of the LLC will have all of the rights and obligations of an original Member under the Operating Agreement. Any transferee of a Member's Units in the LLC must be treated as an Assignee until that transferee is admitted as an Additional or Substitute Member, if ever, under the Operating Agreement.

SECTION 12 OPERATING AGREEMENT AND AUTHORITY

To the extent not expressly required by and provided for in the Act, the manner in which the LLC conducts its business and affairs, the duties and authority of its Member, and the rights and obligations of its Member must be set forth in the Operating Agreement adopted by the initial Member of the LLC. This Operating Agreement may be amended from time to time according to its provisions.

SECTION 13 MANAGEMENT

Management of the LLC is reserved to the Member, who will manage the LLC. The Member has exclusive authority to act for the LLC in all matters. The authorities and duties of the Member are set forth in the Operating Agreement.


SECTION 14 INDEMNIFICATION AND LIABILITY

As determined by the Member of the LLC, the LLC may indemnify and advance expenses to a Member, employee, or agent of the LLC in connection with any proceeding, to the extent permitted by applicable laws and statutes, the Act, and the LLC's Operating Agreement.

SECTION 15 TRANSFERABILITY OF INTEREST

Interest in the LLC is nontransferable except as specifically set forth in the LLC's Operating Agreement.
