ARTICLE IV - DURATION

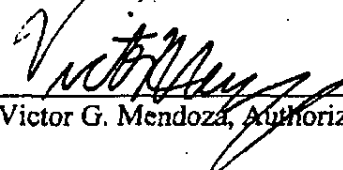
