ARTICLES OF ORGANIZATON

OF

ALL-STAR GRADING AND SITE WORK LLC

- 1. Name. The name of this limited liability company is ALL-STAR GRADING AND SITE WORK LLC (the "Company"), and it shall be formed as a limited liability company tunder the Florida Limited Liability Company Act.
- 2. <u>Existence</u>. The Company shall have perpetual existence, commending upon the date of filing of these Articles with the Florida Department of State.
- 3. <u>Principal Place of Business</u>. The mailing address of the Company's principal place of business is 15021 Third Street, Bokeelia, Florida 33922.
- 4. <u>Purpose</u>. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida, including but not limited to grading and site work and related works.
- 5. Registered Agent and Office. The name of the initial registered agent of the Company is Melville G. Brinson III. The street address of the initial registered agent of the Company is 8359 Stringfellow Road, St. James City, Florida 33956.
- 6. <u>Management of the Company</u>. The Company shall be managed by the members and is, therefore, a member-managed company. The initial Managing Member is Juan Carlos Perez, 15021 Third Street, Bokeelia, Florida 33922. The actions of the Managing Member shall be sufficient to bind the LLC.
- 7. <u>Termination Of Membership</u>. Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall be dissolved unless the remaining members, by unanimous written agreement, consent to continue the business of the Company.
- 8. Operating Agreement. The Managing Member shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.
- 9. <u>Regulations</u>. The member shall have the power to adopt, alter, amend, or repeal regulations of the Company containing provisions for the regulation and management of the affairs of the Company.
- 10. <u>Voting</u>. The Company is authorized to issue membership units with voting rights and membership units without voting rights.
- 11. <u>Certificated Interests</u>. The member's interests in the Company may, in the discretion of the manager, be evidenced by certificates.
- 12. <u>Transfer of Interests</u>. No member shall have the right to transfer any interest in the Company without the unanimous written agreement of all members. If the non-transferring members do not approve the transfer, the transferee of the interest of the transferring member shall have no right to become a member or to participate in the management of the business and the affairs of the Company. The transferee shall be entitled to receive only the share of



profits or other compensation by way of income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of membership.
