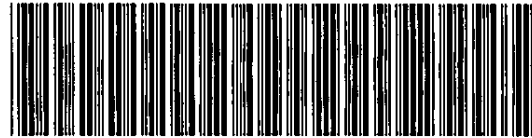

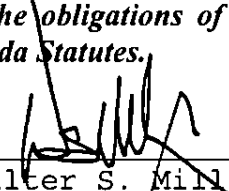

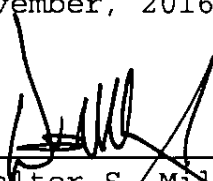
Members Rights to Continue Business
