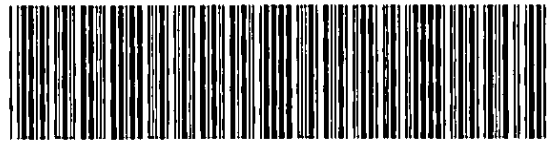

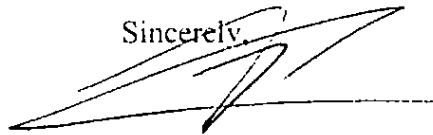

FOR

Article I

Name

The name of the limited liability company is Canal Street Land Group, LLC ("Company").

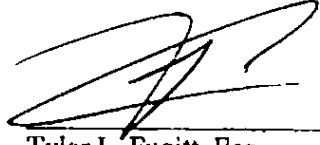

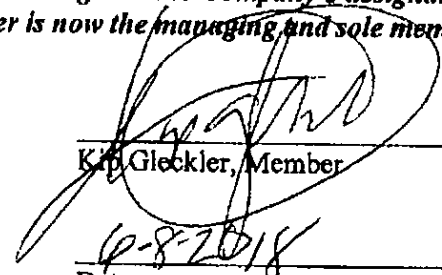
