ARTICLE VI - ADMISSION OF ADDITIONAL MEMBERS

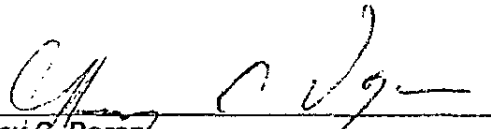

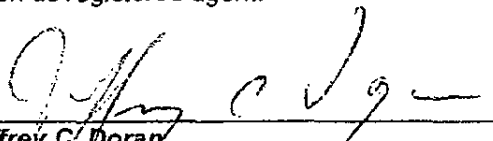
ARTICLE VIII - EFFECTIVE DATE
