The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I – Name

The name of the Limited Liability Company is ELITE MD GROUP, LLC (the “Company”).

ARTICLE II – Address

ARTICLE III – Duration

The Company shall commence its existence as filed by the Florida Department of State. The Company’s existence shall be perpetual, unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE IV – Registered Agent and Registered Office

ARTICLE V – Capital Contributions

Capital contributions in cash or in kind shall be paid to the Company by the members in such amounts as the Managing Members shall determine.

ARTICLE VII - Admission of New Members


