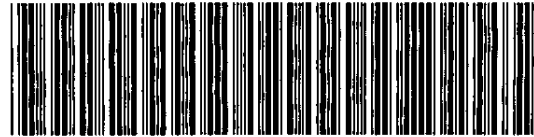



The Limited Liability Company is to be managed by managers. Each manager shall have full authority to act independently on behalf of the Limited Liability Company. The name and addresses of the managers are:




