**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION**

OF

The undersigned acting as the organizer of EC CUBED, LLC, under the Florida Limited Liability Company Act, Chapter 605, *Fla. Stat.*, adopt the following amended and restated Articles of Organization which were filed on December 15, 2016 and assigned Florida document number L16000220194:

**ARTICLE I - Name:**

The name of the limited liability company is EC CUBED, LLC (the "Company").

**ARTICLE II - Address:**

**ARTICLE IX - Member Interests:**

The Company is authorized to issue both voting and nonvoting membership interests. All membership interests shall be identical in all respects except the nonvoting membership interests shall carry no right to vote on any matter except as the State of Florida requires that voting rights be granted nonvoting membership interests.
