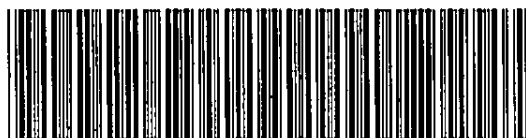


AMENDMENT REQUESTED

Article III to be amended to read: Non profit funding raising organization supporting the Sarasota County Youth agricultural projects and is organized exclusively for charitable and educational purposes with the meaning of Section 501(c)(3) of the Code, including, for such purposes, but not limited to the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Code or the corresponding provision of any future United States internal revenue law. Included in the general purposes described in the previous sentence are: (i) promoting the understanding of and critical thinking of leadership development on issues, questions and values in the fields of livestock care and development; (ii) encouraging research in areas of crop growth including rotation; (iii) stimulating effective instruction; (iv) promoting publications in the field of farming and ranching operations; (v) serving the professional interests of Members as students and teachers; (vi) fostering communication and exchange among teachers and students and enhancing the public's understanding of plan and animal husbandry.
