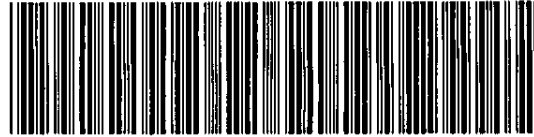

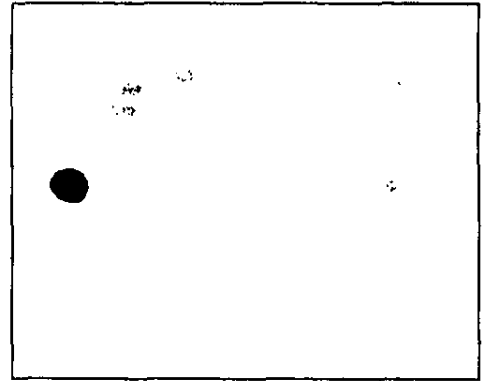

NAME


