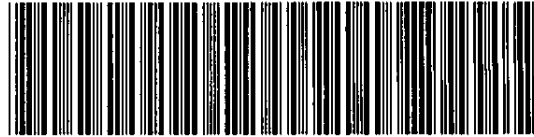

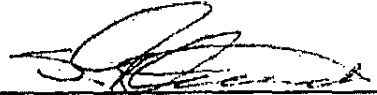
**ARTICLES OF CONVERSION FOR
