ARTICLE 1 - NAME

The name of the limited liability company shall be I-INITIATE USA, LLC ("Company").

ARTICLE 2 - ADDRESS

ARTICLE 4 - DURATION

Subject to the provisions of Article 8, the Company's existence shall terminate no later than 99 years from its date of commencement, unless the Company is earlier dissolved as provided in these Articles of Organization.

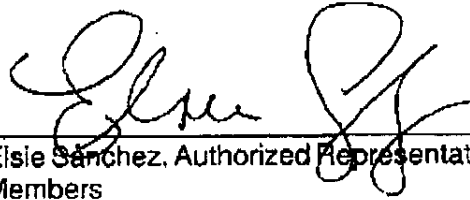

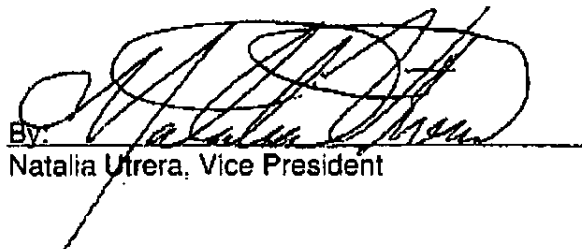
