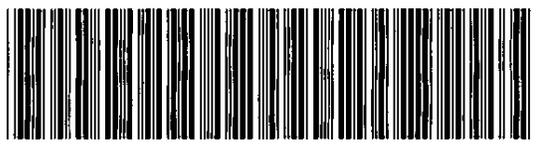

Name
