**ARTICLES OF ORGANIZATION  
OF  
PUGS I, LLC**

1. Name. The name of this limited liability company is PUGS I, LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Duration. The Company's existence shall be effective as of December 9, 2016 and shall thereafter be perpetual.
