**ARTICLE V**



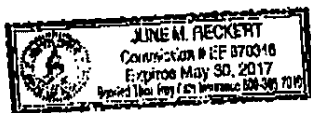
