The undersigned, an authorized representative, hereby subscribes to these Articles of Organization to form a limited liability company (the "Company") under the Florida Revised Limited Liability Company Act (Chapter 605, Florida Statutes) and the Professional Service Corporation and Limited Liability Company Act (Chapter 621, Florida Statutes) and in accordance with F.S. § 605.0201.

**1. Name.** The name of the Company is:

**Fundamental Psychology, PLLC**

**2. Purposes.** The purposes for which this Company is organized are as follows:

To acquire, establish, own, maintain, manage, operate, conduct, carry on and engage in the practice of psychology, and to make any and all investments and/or own any and all property in the United States or elsewhere authorized or permitted by Chapters 605 and 621, Florida Statutes.

In the course or furtherance of such practice of psychology, to invest funds in real estate, mortgages, stocks, bonds or any other investments of any conceivable type whatsoever, and to own any real or personal property necessary or incidental to such practice of psychology.

In general, to do and perform any and all acts and things whatsoever which may be or become necessary, desirable, proper, convenient, connected with or related or incident to the foregoing purposes or powers but which are not forbidden by the laws of the State of Florida; provided, however, that this Company shall not do any act or thing in conflict with any laws of the State of Florida applicable to the practice of psychology.

**3. Mailing Address and Address of Principal Office of Company.** The mailing address and the principal office address of the Company is 1531 Tamiami Trail South, Suite 703, Venice, Florida 34285.

No member of the Company shall enter into any type of agreement vesting another person with the authority to exercise any of that member's voting power in the Company.
