ARTICLES OF ORGANIZATION

OF

Pursuant to the provisions of Chapter 605 of the Florida Statutes, the undersigned hereby declares the following provisions as the Articles of Organization of PATTY'S BEACH HOUSE, LLC, a Florida limited liability company (the "Company").

ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Company is PATTY'S BEACH HOUSE, LLC and its principal office and mailing address is 5 Stonegate Drive, Belleair, FL 33756.

ARTICLE 2: DURATION

The duration of the Company is perpetual, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of the State of Florida.

ARTICLE 3: PURPOSE


ARTICLE 6: LIMITATION OF AGENCY AUTHORITY OF MEMBERS


