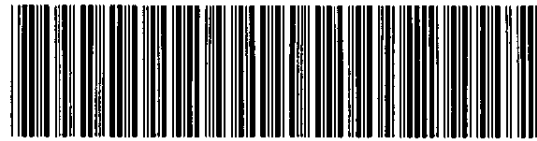

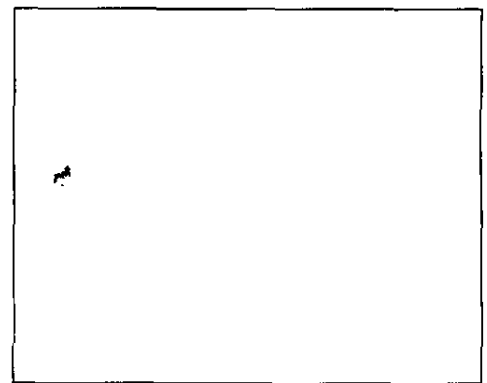

NAME


