**ARTICLES OF ORGANIZATION

1. Name. The name of this limited liability company is **JG REAL ESTATE PARTNERS II, LLC**, a Florida limited liability company (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.
