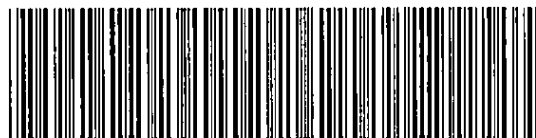

The Surviving Company agrees to pay any members with appraisal rights the amount, to which members are entitled under Section 605.1006 and 605.1061-605.1072, F.S.



The Merger shall become effective upon the filing of these Articles of Merger with the Department of State of the State of Florida.


