AGREEMENT

Leonid Koulik and Michael Petzold take the following agreement:

The two are equal partners in M & L. Coasal Construction LLC and have purchased a lot at 3218 Ocean Shore Blvd Flagler Beach Fl 32136.

The total land of about 3,5 acres has been divided into three lots starting with the northern lot of 90 feet, next 90 feet and 120 feet width along Ocean Shore Blvd.

Both partners have informally agreed to divide the two northern lots individually for sale and keep the last lot in common.

Leonid Koulik sold his part of the property and Michael Petzold ist to do the same, thus remains the common property with the street dimensions of 120 feet.

It is agreed as of today that Michael Petzold will fully pay the loan for the last lot to the governor of the mortgage Connie Revals, 225 Michael Dr., Saint Augustine, FL 32086 of approx. \$ 100,000.
