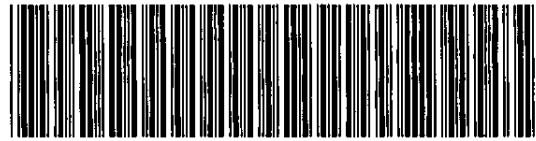

ARTICLE I
NAME & EFFECTIVE DATE
