Articles of Organization of Erasec Creative , LLC

THESE ARTICLES OF ORGANIZATION forming a limited liability company under the laws of the State of Florida are made and executed this <u>14th day of December</u>, <u>2017</u>, by the undersigned.

- 1. **Name**. The name of the limited liability company is ERASEC CREATIVE, LLC (hereinafter referred to as the "Company").
- 2. **Term**. The term or period of duration of the Company shall commence as of the 7th day of January, 2017 and shall continue for a term of thirty (30) years from that date, unless sooner terminated pursuant to law or the provisions of the Company's Operating Agreement.
- 3. **Business Purpose**. The character and purposes of the Company and its business are (1) to provide services; (2) to engage in any and all lawful business and activities for which companies may be organized under the laws of the United States of America and the State of Florida;
- 4. **Registered Office and Agent**. The street address of the Company's registered office and principal place of business is <u>1020 Villa Lane</u>, <u>Boynton Beach</u>, <u>Florida</u> <u>33435</u>. The name of the Company's initial registered agent at that address is Cesare Turner.

Having been named as registered agent and to accept service of process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statues relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations as registered agent as provided for in Chapter 605, F.S..

5. **Management**. The management of the company shall be vested in the Managers and a majority of the Managers voting shall be necessary for all decisions affecting the Company. The Managers shall serve until their successors are appointed or until their resignation or removal. The initial Managers of the company authorized to manage and control the Company and their addresses are as follows:

6. **Members**. This company will have two (2) or more Members upon formation and will always maintain at least two (2) Members. New Members may be added to the Company only with the unanimous consent of all the existing Members. If a Member sells or assigns an interest in the Company, the purchaser or assignee is entitled to all of the financial rights of the selling or assigning Member in the Company. The purchaser or assignee is not permitted to participate in the management of the Company without the unanimous consent of the non-selling Members.

As provided in the Company's Operating Agreement, certain powers are vested solely in the Members, acting unanimously, and in the event all Managers resign or are removed from office as provided in the Company's Operating Agreement, the business of the Company shall be under the exclusive management of the Members, acting unanimously.

- 7. **Continuation of Business**. Under the terms of the operating agreement, the Members may not continue the business without dissolution upon the death, expulsion, resignation, or withdrawal of a Member from the Company without the consent of all of the remaining Members.
- 8. **Non-statutory Grounds for Dissolution**. The Members agree that the non-statutory grounds for dissolution of the Company are as follows:
 - a. Non-statutory grounds for dissolution of the Company shall be a unanimous vote of then-remaining Members.
- 9. **Member Liability**. The Members will not be liable for the debts, obligations, or liabilities of the Company or for any claims made against it.
