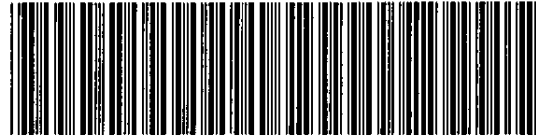

The name of the Company shall be Pig Properties, LLC.




