Pursuant to the provision of Section 605.0202 of the Florida Revised Limited Liability Company Act, the undersigned adopts the following Articles of Amendment to its Articles of Organization:

The mailing address of the Company is 5458 Town Center Road, Suite 19, Boca Raton, FL 333486.


4. Article III of the Articles of Organization of the Company is amended by deleting the address of the registered agent and substituting in its place the following address:
