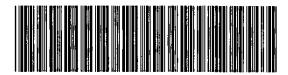

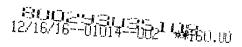

A FLORIDA LIMITED LIABILITY COMPANYALLA

ARTICLE I - NAME

The name of the limited liability company is DIVING FOR HISTORY, LLC.

ARTICLE II - ADDRESS

ARTICLE VIII - MEMBER'S RIGHTS TO CONTINUE BUSINESS

The remaining members of the limited liability company may continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company.

ARTCLE IX - EFFECTIVE DATE

Pursuant to the provisions of Chapter 605 of the Florida Statutes, this limited liability company shall begin its existence on January 1, 2017.
