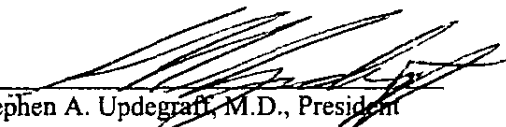

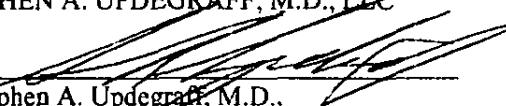

MANAGEMENT

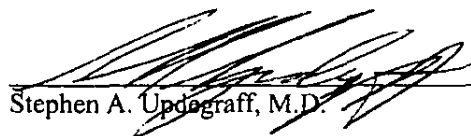

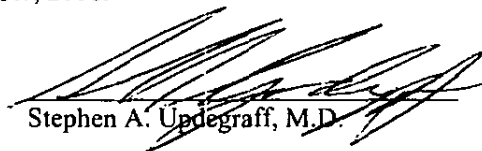
