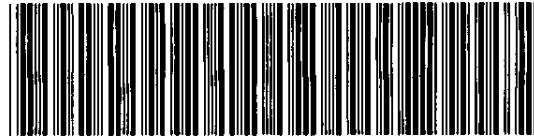

**ARTICLES OF ORGANIZATION
OF
DEBUEL PROPERTIES, LLC**


