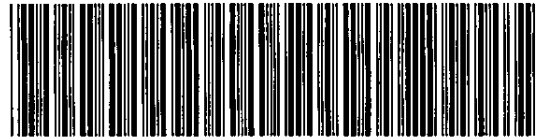

**ARTICLE I  
NAME & EFFECTIVE DATE**
