ARTICLES OF AMENDMENT TO THE ARTICLES OF ORGANIZATION OF MEXBRIT LLC

2017 JULII AM 10: 28

Pursuant to the provisions of the Florida Revised Limited Liability Company Act (the "Act"), Mexbrit LLC, a Florida limited liability company (the "Company"), registered under Florida Document No. L16000232484, adopts the following Articles of Amendment to its Articles of Organization:

ARTICLE I Name

The name of the Company is Mexbrit LLC.

ARTICLE II Amendment to the Articles of Organization

A new Article VII of the Articles of Organization of the Company is hereby added, to read as follows:

"ARTICLE VIL PURPOSE

The purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States including, but not limited to: (i) engaging in the business of reinsurance; (ii) acting as an insurance or reinsurance broker, intermediary or entity; and (iii) acting as an intermediary for the insurance or reinsurance of foreign risks with the capacity to act as reinsurance intermediary of risks coded from abroad.^{11C}

ARTICLE III Date of Adoption

This amendment to the Articles of Organization of the Company (the "Amendment") was adopted on the 5th day of July, 2017.

ARTICLE IV Manner of Adoption

Pursuant to the provisions of the Act, effective July 5, 2017, the sole Member and the Managers of the Company duly approved and adopted the Amendment through a joint written action taken by the unanimous written consent of the Member and Managers.

Accordingly, the Amendment has been authorized by all appropriate action under the Act.
